6. Hospitality industry: modern challenges and prospects.

**The languages of the conference are Ukrainian and English.**

**Terms of participation in the conference:**

2. Send the electronic version of the article in English or in Ukrainian on [conference@udpu.edu.ua](mailto:conference@udpu.edu.ua) (the name of the article should include the name of the first author and section number as in the example: Petruk\_ Article\_5.docx).
3. After receiving the materials, their verification for compliance with the requirements of publication and filling the registration form, the Organizing Committee informs the authors about their acceptance and sends details for payment.
4. Copy of payment receipt.
5. The texts of the articles must be original, carefully edited, and the authors are responsible for their content.
6. Articles that do not meet the requirements or submitted later than the deadline date will not be considering.
7. According to the results of the conference, the articles will be published in the electronic periodic interdisciplinary scientific journal **Sustainable Socio-Economic Development Journal** with DOI assignment, which will provide automatic indexation in CrossRef, Google Scholar, NBUs, and other repositions.

**The deadline of the materials submission is May 5, 2023.**

## Design requirements

The total volume of articles is from 2500 words of A4 text at typed in the MS Word editor. All fields - 20 mm, headset - Cambria, skittles (size) - 12, spacing interval - 1, paragraph indent - 10 mm.

Table and graphic material (kegl 8–10, font - Calibri, interval - 1) should have a number and title. The number and name of the table are placed in the center above the table, the number and name of the figure - in the center under the figure. All graphic objects should be available for formatting and amending, so files with such objects together with the text of the author manuscript are needed in appropriate editors.

**The editorial board recommends that when writing an article to adhere to the following structure:**

1. At the beginning of the first page, the name of the article in Ukrainian and English is placed.

2. The next line contains comprehensive metadata of the author (s) of articles in Ukrainian and English: fully first name, patronymic and surname, scientific degree, academic title, position, place of work (training), postal address, country, e-mail address, e-mail address, ORCID. You must also specify the correspondent author and his mobile phone number.

3. Annotations in Ukrainian and English (at least 250 words or 1800 characters with spaces). The abstract reflects the summary of the manuscript, which is divided structurally into the following obligatory elements:

- Purpose;
- Design / methodology / approach;
- Findings;
- Originality / value;
- Theoretical meaning;
- Practical meaning;
- further research;
- Manuscript type.

4. **Keywords.** Each article needs to form keywords and/or phrases in Ukrainian and English, which will best reflect its content and which will be indexed. Keywords should not repeat the words from the article. They should be at least 5 and no more than 10.

5. **JEL Classification.** It is formed for keywords and is a generally accepted method of classification of subject matter of economic research, developed by the American Economic Association: <https://www.aeaweb.org/econlit/jelCodes.php?view=jel>

6. **The text of the article,** taking into account the requirements of the Decree of the Presidium of the Higher Education of Ukraine No. 7-05/1 of 15.01.2003, is formed in the following sections:

1) **Introduction.** The introduction poses in the general form and substantiates its connection with important scientific or practical tasks.

2) **Literature Review** It should include an analysis of recent research and publications (preferably not before ten years) in which the problem is being solved and the author is based. At the end of the literature review, unresolved parts of the total problem dedicated to the article should be distinguished;

3) **Problem Statement** – it is necessary to formulate the main purpose of the study and the goals to be achieved;

4) **Materials and Methods** – the main sources of statistical information and research methods should be characterized.

5) **Results and Discussion** – This is a presentation of the basic material of the study with full substantiation of scientific results, as well as their comparison with similar results, including the characteristics of potential difficulties and possible ways of overcoming them.

6) **Conclusions** – It is evaluated whether the purpose and purpose of the research is given, proposals and recommendations are given, the effects of the conducted research (social, economic, environmental, etc.), scientific novelty of the study, practical value and ways of application of research results, as well as prospects of further exploration are given, specifies the results and recommendations.

7) **Author Contributions** – Depending on the activities of the co-authors in the preparation of the manuscript, it is necessary to distinguish the contribution of everyone - from the idea to submission to the editorial board - in the following areas of work:

- Conceptualization and Design;
- Literature Review;
- Methodology and Validation;
- Formal Analysis;
- Investigation and Data Collection;
- Data Analysis and Interpretation;
- Writing – Original Draft Preparation;
- Writing – Review & Editing;
- Supervision;
- Project Administration;
- Funding Acquisition.

8) **Acknowledgment** – This section is formed only if the thanks are needed to anyone who helped co-authors in the work on the manuscript, including the scraper and/or state budget topic within which the study is completed in the event of external funding.

9) **Appendices** – are formed if necessary.

10) **References** Designed in APA style: <https://apastyle.apa.org/style-grammar-guidelines/references/examples> by alphabet Slovník.ua/translit.php; Russian <https://translit.ru/ru/bsi>, and in square brackets is obligatory translated into English.

Authors who refer to Ukrainian -language and Russian -language sources should submit their bibliographic descriptions in DSTU 8302: 2015: [http://lib.znau.edu.ua/jirbis2/images/phocagallery/2017/Pryklady\\_DSTU\\_8302\\_2015.pdf](http://lib.znau.edu.ua/jirbis2/images/phocagallery/2017/Pryklady_DSTU_8302_2015.pdf).

Without the URL, only printed sources are quoted, digital copies of which are missing on the Internet! It is not allowed to place bibliographic descriptions of sources in the References section without their quotation in the text of the manuscript! The vast majority of sources should be in the last 5 years and have an active DOI identifier. It is desirable that references to publications in journals indexed in Scopus and/or Web of Science prevailed. The number of sources used is at least 20!

APA style is used for citation. When designing quotations in the text, the rules of quotation governed by APA style should be observed.

References to literary sources in the text are made exclusively in round brackets! For example: (MSdouglass, 2013, p. 46). References to 2 or more sources are made as follows: (Mishchenko, 2021, p. 46; Marshal, 2012, p. 85, 102-103; Lysohor, 2010, p. 178) in reverse. Other cases of citation:

- three source co-authors - (Marshal, Marchenko, & Lysohor, 2019, p. 46);

- four or more source co -authors - (Marshal et al., 2019, p. 86);
- the author is the organization - (The World Bank, 2016);
- without the author - (the name of work instead of the author at the first mention completely, then it is possible to abbreviated);
- edited - (Marshal (ed.), 2019, p. 46);
- one author, different years - (Marshal, 2013, p. 46; 2015, p. 103);
- one author, one year - (Marshal, 2018a, p. 46-48; 2018b, p. 13);
- reference to law or other normative acts - (The Verkhovna Rada of Ukraine, 2012 - Year of adoption).

The sources in the list are not numbered, but are organized in alphabetical order by the names of the authors and in chronological order, when references to more than one work of one author (by year of publication, starting from the earliest) are made.

If several works of one author (a team of authors) are cited, published in the same year, then in the References list they are placed alphabetically, based on the titles of work; In this case, the small Latin letter A, B, C....

In the section "Literature Review" in the Ukrainian version of the manuscript near the name and initials of the authors, it is obligatory in brackets to indicate their name, translated into Latin with the year of publication in the list of literature. For example: G. Bohras (Bohras, 2015, 1995), S. Rodrigas (Rodrigas, 1985), J. Bakhvati and K. Ramada (Bakhwati, & Ramada, 1984;), G. Vrubel and A. Prescott (Vrubel, & Prescott, 1976).
