- 4. After payment, send a copy of the receipt to e-mail of the organizing committee (the name of the document should correspond to the sample: 5\_Smith\_ Payment.pdf).
- 5. The texts of conference papers should be original, carefully edited, and the authors are responsible for their content.
- 6. If conference paper will not meet the requirements or will be submitted after the deadline the organizing committee will not consider them.
- 7. Conference papers will be published in the conference proceedings after the conference ending.

The deadline for submission – May 5, 2024.

#### **Requirements for conference papers:**

The number of pages of conference papers is 3–5 of A4 format, text should be typed in MS Word. All margins are 20 mm, font – Times New Roman, size – 14, line spacing – 1,5. The title is written in capital letters, bolded and centered. After the title of the conference paper you should place the author's name and initials, information about the academic degree and academic title, place of work or study on the right side of sheet. To create formulas, graphs, and tables, use the utilities built into MS Word.

The references should be designed in APA style.
